
Madam/Sir,


I am to inform you that while forwarding Post-Matric Scholarship applications of SC/ST/OBC/SEBC/EBC category on OSSP portal for the year 2023-24 the following few points needs to be given utmost importance and consideration.

- While forwarding Renewal Post-Matric applications for the academic year 2023-24, it is mandatory to provide the last exam details of the applicants.
- Incase of Exam conducted but result not yet published, the Admit Card of the applicant needs to be uploaded and the same needs to be mentioned in the Remarks.
- Incase Exam is not conducted at all, then the same has to be mentioned in the Remarks column clearly & immediate previous exam result/ admit card needs to be uploaded with clear remarks.
- Incase of EBC category, Sub Caste has to be mentioned.
- Properly check the scan copies of Income Certificate, Caste Certificate, First page of bank passbook, Hosteller Bonafide Certificate (in case of hosteller), Disability Certificate (if any) and all Educational certificates uploaded by the applicant.
- In case any of the documents is not properly legible then application should be reverted to the student level with proper remarks.
- It is advisable to scan the QR code given in certificates for checking its authenticity. In case of any discrepancy/doubt the application should be reverted/rejected immediately, as the case may be.

This may be treated as Utmost important.
