- Each page of the tender paper has to be signed and stamped by the firm/Supplier.
 - Earnest Money Deposit (EMD):** EMD (also known as Bid Security) is to be submitted by the bidder along with the bid in shape of either account payee demand draft or fixed deposit receipt or banker's cheque or bank guarantee in favor of Principal, Maharishi College of Natural Law, Bhubaneswar, payable in any nationalized Bank at Bhubaneswar.
